1. MAYA is strictly a non-smoking zone and consumption of any type of alcohol, tobacco, and drugs etc. is strictly prohibited. Violation of code of conduct would invite serious measures and even suspension.
2. Mobiles must be switched off inside the academic block, administrative block and library. If a mobile rings within these blocks then penalty shall be obligatory on the scholar.
3. All students must attend the college as well as all college functions in prescribed college uniform.
4. Students must reach college at scheduled time.
5. All students are expected to be inside the classroom before the faculty member enters the class. Students shall not be entertained to attend any class if he/she is late.
6. All students must obtain minimum 75% attendance in theory as well as in practical classes in each subject to be eligible for internal as well as university examinations. Any student who fails to obtain the minimum attendance shall be debarred from University and Semester examinations.
7. Any misconduct or misbehaviour in the Institute campus/Hostel or outside shall be viewed seriously and liable to be penalized accordingly.
8. Students must abide by the rules and regulations enforced from time to time by the University.
9. It is mandatory for students to clear all their dues before examinations, failing which the student shall be debarred from the examinations.
10. Students are expected to follow all the rules and regulations of the library.
11. Ragging or any act that causes mental and physical harassment to another student will invite penal action/penalty and the offender is likely to be expelled from the institute.
12. The institute does not hold itself responsible for any debts or financial deals made by students or their parents.
13. Students are not allowed to use extra electrical fitting in their rooms unless permitted by the hostel Authorities.
14. Students should not keep large amount of cash or costly items like mobile phones, Camera, electronic gadgets, jewellery, etc. in their rooms. Management will not be responsible for any theft or loss of goods.
15. Students could not leave the hostel in the mid-session, if they leave have to pay complete one year fee.
16. Students can not celebrate any type of party without prior written permission of hostel warden
17. Any type of scholarship can be cancel if students have any back paper or attendance will be less than 75%.
18. Smoking, consumption of alcoholic drink and use of narcotic drugs in the hostel premises is strictly prohibited. Neither the students nor their visitors are allowed to bring or consume liquor, drugs, or any other intoxicants in the hostel premises. Severe action will be taken against those in possession of drugs.
